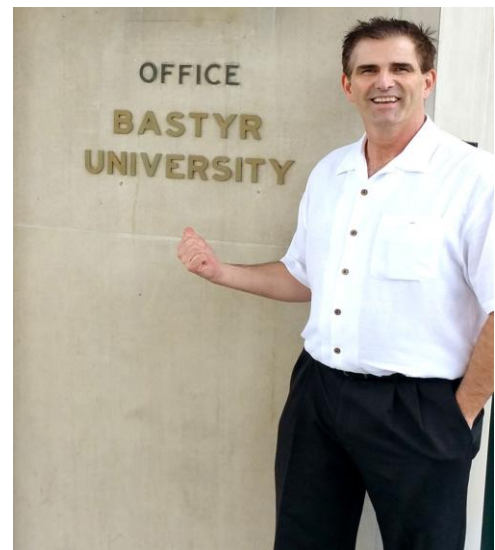
Dr. Kaleb Lund of Herbal Analytics awarded Research Grant from Bastyr University in Washington State for new Drug Discovery.
