The Property lies within the Beardmore-Geraldton-Tashota greenstone belt, approximately 80 km northwest of the town of Geraldton and 240 km northeast of the City of Thunder Bay in Northwestern Ontario. The Property comprises four mining leases and twenty-five mining claims.**

The disclosure should be sufficiently complete to enable a reader to appreciate the significance of the acquisition without reference to any other material: **The Issuer became a party to an option agreement dated April 11, 2024 (the "Option Agreement") with arms-length third party optionors (the "Optionors"), pursuant to which the Issuer has an option to acquire a 50% interest in the Property (as defined above). The Option Agreement was originally entered into between the Optionors and Advantel Minerals (Canada) Ltd. ("AMCL") in July 2018 and was assigned by AMCL to Tashota Resources Inc. ("Tashota") on November 3, 2021. Tashota has now assigned 50% of its interest under the Option Agreement to the Issuer. As consideration for the assignment, Trojan has agreed to issue 5,000,000 common shares to the Optionors at a deemed price of \$0.05 per common share.**

## **Appendix A**

### **PERSONAL INFORMATION COLLECTION POLICY REGARDING FORM 9**
