During the month of April 2024, the Issuer remained subject to a voluntary management cease trade order (the "MCTO") in accordance with National Policy 12-203 Management Cease Trade Orders ("NP 12-203") granted by the British Columbia Securities Commission, due to it not being able to file its annual financial statements and management's discussion and analysis ("MD&A") for the year ended March 31, 2023 on SEDAR within 120 days of its financial year-end.

The Issuer was not in a position to complete the year-end audit within the required time period due to a change of the Company's auditor to MNP LLP. As the Issuer did not file the foregoing annual financial statements and MD&A by September 29, 2023, the BC Securities Commission issued a general failure to file cease trade order against the Issuer on October 10, 2023. On October 11, 2023, the CSE issued a bulletin announcing that the Issuer has been suspended pursuant to CSE Policy 3. The suspension is considered a Regulatory Halt as defined in National Instrument 23-101 Trading Rules.
