The company owns a 100% interest in the Nevasca Lithium Project located in the Arizaro Salar in Salta, Argentina, for which the company has entered into an option agreement with NOA Lithium Brines Inc. Maverick also controls in excess of 1.6 M shares of Noram Lithium Corp. (TSX-V: NRM) which is developing the Zeus Lithium Deposit in Clayton Valley Nevada, adjacent to Albemarl's Silver Peak Lithium mine and production facility. CDN Maverick also controls a 100% interest in the Rainbow Canyon Gold Project in the Olinghouse Mining District, in the Washoe County Nevada. The company acquired 7,040 hectares in the "Electric Avenue", an emerging lithium pegmatite exploration camp in the Red Lake area, Ontario, contiguous to Frontier Lithium's PAK Lithium Project and 40,000 hectares in Quebec's James Bay area.
